

### ***Tenderer's Technical Questionnaire (Note 3)***

A technical questionnaire is to be provided by the Economic Operator in response to the Technical Specifications. The submission shall be in a structured form and is to be in the same sequence as listed hereunder for ease of reference and evaluation.

Failure to duly submit the information requested hereunder will result in disqualification of the offer. Bidders must include this form as part of their technical offer in addition to the Tenderer's Technical Offer. The technical questionnaire falls under Note 3 (No rectification is allowed). In this regard, the information/technical specifications provided in the below table shall not be subject to rectifications. Therefore, bidders that fail to complete in full, duly sign, submit the requested information will be deemed as non-compliant and will result in disqualification of their offer.

Where in this tender document a standard is quoted, it is to be understood that the Contracting Authority will accept equivalent standards. However, it will be the responsibility of the respective bidders to prove that the standards they quoted are equivalent to the standards requested by the Contracting Authority.

The items being offered in must be in conformity with the specifications requested under Section 4 - Technical Specifications, the Financial Plan and any Drawings issued

The Technical Questionnaire shall constitute the following:

#### **1. Statement of Compliance with the General and Special Conditions of the Tender Document**

The bidders need to confirm that it has read the General Conditions and Special Conditions presented within the Tender Dossier and must confirm that it is in a position to execute the contract in line with these parameters.
